2023 New “Players Club” Membership Agreement

- Club Membership includes privileges beginning on the date of contract and when the initiation fee is accepted.
- Initiation fees and membership dues are non-refundable.
- Membership dues are charged monthly. Automatic payment method on file is required.
- Accounts over 30 days past due will be subject to a \$25 late fee each month until full balance has been paid. Accounts over 60 days past due will be suspended until the account is paid in full.
- Conduct detrimental to the use of the golf course, other members, guests and/or staff may result in termination of membership. TPC Myrtle Beach reserves the right to revoke or deny any memberships at any time.
- Membership dues and/or playing fees may increase at the discretion of the club.
- Proper golf attire is required (including practice facility.)
- Members may book starting times one week in advance. Starting times may be booked in the Golf Shop or by calling 843-357-3399.
